

NEURAL CONSULT - TERMS AND CONDITIONS OF USE

Welcome to Neural Consult, an artificial intelligence-powered medical education website located at www.neuralconsult.com (The “Website”).

This site is owned and operated by Dendritic Health AI, LLC (The “Company” or “Dendritic Health”) whose office is located at 2222 W. Grand River Ave STE A, Okemos, MI 48864. By using our website, you agree to the following terms and conditions (The “Terms”). If you do not agree to the Terms, policies and conditions of these Terms, any additionally documents including the Privacy Policy (Section “Privacy”), you may not use the Website. Dendritic Health reserves the right to modify these Terms at any time. It is your responsibility to review the Terms be for each use of the Website.

- 1) **Purpose of the Website:** Our website is for educational purposes only and is not intended to provide medical advice or patient care. 3) License and Subscriptions

- a) **License:** In consideration of and subject to your payment of the appropriate subscription fee for the site features you subscribe to, and your agreement to and compliance with the terms, policies and conditions set forth in these Terms, Dendritic Health grants to you a limited, revocable, non-exclusive, non-sublicensable, non-transferable license to use and access the content and features posted at the Website according to the terms, policies and conditions set forth in these Terms.
- b) **Term:** The Term of these Terms and the license granted in these Terms shall be concurrent with the term of your subscription to the Website ("Term") and may be terminated earlier than the expiration of your subscription as provided below

This pricing and Term is subject to change without notice. Void where prohibited, taxed, or restricted by law.
- ii) **Paid tier:** Eligible users can purchase a paid subscription for access to all of the site's published tools and features for \$19.99/month or \$180/year. At the end of the Subscription Term as outlined in section 3(g), you will be billed automatically unless your subscription is cancelled. Cancellation is available any time outlined in section 3(h). Access may be limited if judged as abusive (including but not limited to, using the site beyond any reasonable amount of studying would require) or violates these Terms in any way as judged by the sole discretion of the Company. This pricing is subject to change in accordance with section 3(e). Void where prohibited, taxed, or restricted by law.
- e) **Fee Increase:** The Company reserves the right to increase fees for any services, upon thirty (30) days' prior written notice, effective on the start date of your subsequent subscription term.
- f) **Member Account/Password and Security:** You must complete the Website's registration process in order to subscribe to and use the Website by providing us with current, complete, and accurate information as prompted by the registration form. You also will choose a password and a Username. You are entirely responsible for maintaining the confidentiality of your password and account. Furthermore, you are entirely responsible
